**FOOTING:** Grass and/or Clay/Sand main ring & warm-up.

**CONCESSION:** There is no concession on the show grounds.

**NOTE:** Management reserves the right to add or divide classes. All pets must be leashed. Juniors must wear protective headgear when mounted. Braiding and jackets are not required. English boots (tall or paddock style) are required. No cowboy boots, or high heeled boots allowed. All entries must be postmarked by **March 11**. No refunds after the closing date.

**DIRECTIONS:** Lake Park is located on the West side of North Dale Mabry approximately 1/2 mile south of the Veterans Expressway/Dale Mabry exit. From Pasco County, take SR 54 west, turn south on 41 and follow Dale Mabry south. From Pinellas go E on 60 then north on the Veterans Expressway. Exit at Dale Mabry, go south on Dale Mabry. From Manatee County, go north on I-75, west on I-4, north on I-275, west on Bearss, then north on Dale Mabry to Lake Park.
